EVENT OVERVIEW:

The Eastern Defense Summit, formerly known as the Annual CDCA Defense Summit, is one of the largest defense-focused events on the East Coast, bringing more than 1,800 government, military, academia, and industry leaders together to better understand and address today's challenges and threats within our defense industry. The Eastern Defense Summit serves as a mechanism for defense industry leaders to collaborate on innovative solutions and other focus areas to enhance interoperability across defense assets. By presenting exhibit demos, keynote addresses, innovation spotlights, and high energy tech exchanges, the Summit will provide an opportunity for all representatives to form workforce partnerships that result in achieving a national defense tactical edge no foreign adversary can match.

Charleston Area Convention Center, International Blvd, N. Charleston SC 29418.
(Five-minute drive from CHS International Airport, adjacent to the Embassy Suites Hotel)

REGISTRATION FEES: (Registration includes lunch both days of the Summit):

- Early Bird - \$550 (register *before* October 11, 2023)
- Advanced - \$675 (register *between* October 11, 2023 and December 4, 2023)
- On-site - \$775 (register *on or after* December 5, 2023)
- Government and Active Duty – Free

Important: Government attendee must meet the [Government Employee Definition](#) and must have a **valid email address** ending in **.MIL** or **.GOV**. ACTIVE Military are free to attend and must meet the following requirements: a) MUST have a Military ID, b) MUST have a valid Government Employee ID. Email address with **.CTR@** (government contractors) or any other email addresses will invalidate registration. Registration will be cancelled if requirements are not met.

- Registration Cancellations received:
 - by October 11, 2023 – 100%, minus \$50 cancellation fee
 - after October 11, 2023 – no refunds

BADGE POLICY:

You must present a government-issued photo ID to pick up your badge. Each person must pick up their own badge.

By registering for the 2023 Eastern Defense Summit, you understand that badge sharing is prohibited. Badge sharing means lending your badge to someone else or using someone else's badge to gain access to any Eastern Defense Summit event. Any lost or stolen badges are subject to a reprint fee of \$50.00. Replacement fees are non-refundable.

Attendees are not permitted to photograph, record, or videotape any portion of the Eastern Defense Summit. Working members of the press are required to pre-register and check in with the CDCA PR firm, Judge PR, prior to photographing and/or videotaping at the show.

Exhibit personnel may photograph and/or videotape only their personnel and equipment within the confines of their booth.

Failure to comply with this policy will result in confiscation of devices or material and administrative action under applicable government guidelines.
